Then, on June 29 there will be a special board meeting to interview the finalists. The board is scheduled to take action on June 29 to announce the name of the superintendent at 6:00 p.m. She conveyed that more detailed information can be found on the district's website.

The board reviewed the 2018-19 board meeting schedule.

Jon Holmen, Associate Superintendent, Student and School Support Services, presented a program report on Student Discipline and Restorative practice.

Matt Manobianco, Associate Superintendent, Student and Professional Learning Services, presented a program report on Career and Technical Education.

Mike Van Orden, Associate Superintendent, Student Academic Success Services, presented an update on Special Education and the Washington Integrated System of Monitoring (WISM) which was conducted by Office of Superintendent of Public Instruction on March 28 and 29. He also reviewed the 5-Year Action Plan Updates (pre-referral process for English Language Learners, Multi-Tiered System of Supports (MTSS) and implementation of a pilot program, Dyslexia and implementation of programs to be piloted, Co-teaching, and Professional Development and Curriculum). He also provided an update on adaptive PE at the secondary level, location of a Transition II program from Kamiakin to a location in Kirkland, along with FM/DM equipment upgrades. He responded to board members questions.
